#### **TERMS & CONDITION:-**

#### **EARNEST MONEY**

- 1. Sealed tenders must be accompanied with an earnest money of Rs. 10,000/- (Rs Ten thousand only) in the shape of demand draft drawn on any scheduled bank in favor of Punjab State Warehousing Corporation, payable at Chandigarh. Tenders without earnest money will be rejected.
- 2. The earnest money of successful tenderer would be accepted as security which will be refunded after satisfactory completion of work and no interest would be paid on the earnest money.
- 3. The earnest money of un-successful tenderer (s) would be refunded after finalization of the tender and no interest would be paid on the said amount.

#### **ELIGIBILITY CRITERIA**

- I. The firm must have continued experience of at least two year of providing of annual maintenance contract services of repair & calibration of Moisture Meter to Public / Private Sector organization. Certificate from concerned organization should be appended.
- II. Firm with valid PAN No/GST are only eligible to submit their bid.(Copies are to be attached.)

III. The firm should not be blacklisted or debarred by any Govt./Public Sector undertaking. It should be duly authenticated in the shape of an affidavit attested by Notary from the proprietary of the firm.

### ANNUAL MAINTENANCE CONTRACT

- i. Annual maintenance contract period will be for two years from the date of finalization of contract i.e up to 31.03.2025 and it can be extendable for another one year on the sole discretion of MD, PSWC based on the performance of the firm.
- ii. Service would include repair/ calibration and replacement of mechanical, electrical and electronic parts.
- iii. Annual maintenance contract service rates should be quoted in Rupees per moisture meter
- iv. A.M.C servicing would be conducted at District Hqrs. of PSWC.
- v. Calibration of the Moisture Meter should be undertaken with Hot Air oven only.
- No TA / DA would be granted to the Technician / Representative of party concerned by whom the servicing of moisture meters / tellers would be undertaken at the District Hqrs. of PSWC.
- vii. Servicing of meters shall be done at least twice in a year. (Before the start of Kharif/Rabi season.
- In case need arises for service of moisture meters within a short time and at least 5 Units are required to be serviced, then technician of party would visit the District Hqrs. of PSWC at his own cost and would not claim any TA / DA in case of service of less than 5 Units, the service would be conducted at workshop of the party through the official of the PSWC.
  - ix. The time limit allowed for carrying out service which includes repair / calibration and replacement of parts etc. of moisture meters shall be strictly followed.,

The said work should be completed within 15 days from the date of assignment of work failing which the Corporation shall be at liberty to get the balance work done at their risk & cost from some other party and security of the party will be forfeited.

- xii. In case after the calibration of moisture meters ,the difference of more than the permissible error i.e +/- 0.2% noticed or reported in the moisture meters, the firm will be penalized @2% of the claim or the part thereof.
- xiii. In case ,the firm failed to execute the work satisfactorily or withdraws from the AMC during the contract period ,the security shall be forfeited besides taking further action .
- xiv. After the calibration / repair, the firm will fix one tamper proof seal mentioning the date of calibration/repair. Calubrahon & be done twoys hot an over method.
- In case any dispute relating to this contract arises, the matter would be referred to the Managing Director, PSWC or his nominee for arbitration whose decision shall be final and binding on both the parties. Only the courts at Chandigarh will have jurisdiction to try and decide the disputes.
- xvi. The quantity of the moisture meters can be increased or decreased.
- XVII. The guarantee against the repaired, calibrated or parts replaced will be for six months.
- xviii. The billing will be done for actual No. of moisture meters repaired serviced or calibrated
